- 2. Adjusters must have completed and obtained their Property Technical Certification offered as a third party certification by your company. This certification will give us the assurance that your adjusters have the basic knowledge of insurance principles and policies to be well-qualified adjusters.
- 3. Adjusters must have completed your entire course including the online portions and your onsite intensive training.
- 5. Employment package must include your letter of assurance that they have met their commitment to Veteran Adjusting School and you are ready to stand behind their readiness to enter the industry.
- 6. Adjusters must have the support of your instructors during the initial portion of their deployment in order to ensure timely and quality work submission.

There are two other factors that must be taken into consideration that you and your adjusters must know before we can take them onto our roster.

- 1. All adjusters will be independent contractors and as such are responsible for their own insurances, taxes and all expenses.
- 2. Employment is subject to claim volume and as such we cannot guarantee the number of claims or amount earned to any adjuster on our roster, new or old.
